Financial Task Force Report:

Financial Task Force Report – September 2011 TASL Board Meeting

Future TASL Professional Development

There has been discussion about how to structure future summer professional developments. One suggestion was to have only two days – one in east TN and one in west TN. It would make it easier on the area reps to only have two workshops to facilitate.

It was also mentioned that the summer workshops be presented by TASL members. Kary Barth with KAPCO has expressed an interest in coming back to Tennessee. She doesn't charge us for the workshops, but she likes to have more than one day. Her workshop is most effective when she has at least 3 hours. She could present twice a day and have TASL members also present.

I would like to see vendors more involved with the summer workshops. They can help defray some of the costs. I had talked to several of the company reps and they are very willing to come to the summer workshops.

Attendees loved being able to get their money back. This has kept people from signing up and then not showing up, which has been an issue in the past.

I personally would like to see the area reps scheduling a workshop sometime during January – March. They can work as individuals or in groups. Many librarians want more PD opportunities that pertain specifically to them.

Overall I think the summer was very successful. I know TASL will continue to have fabulous workshops in the future.
