September 25, 2020

Welcome, Introductions and Call to Order

The annual business meeting of the Tennessee Association of School Librarians was held virtually September 25, 2020. President Vicki Winstead called the meeting to order at 5:30 P.M. CST and welcomed members and special guests.

Reading and Approval of Minutes

The minutes from the 2019 annual business meeting and the treasurer's report were included in a shared Google Drive via the virtual chat. The secretary asked members to review these and the president called for additions and corrections. There were none. Brian Seadorf made a motion to accept and Kelly Shipman seconded. Motion passed.

Nominating Committee Recommendations

Jennifer Sharp, Immediate Past President and Nominating Committee Chair, recommended the following slate of officers for 2021:

President- Elect: Katie Capshaw

Secretary: Brandi Hartsell

Treasurer: Dr. Ginny Britt

President Vicki Winstead, asked for nominations from the floor. There were none. President Vicki Winstead asked if there was a motion to accept the slate of officers. Becky Jackman made a motion to accept and Katelyn Jernigan seconded. Motion carries.

Amendments to the ByLaws

The Constitution and Bylaws committee, Chaired by Elizabeth Shepherd, has undertaken an extensive revision of TASL's Bylaws. There are five amendments to the Bylaws being proposed that require a vote by our members. Amending the Bylaws requires a two-thirds majority vote.

Amendment #1:

Proposes changing the wording in Constitution Article V, Section 1 which states, *“and one area representative from each of the nine established TASL regions.”*

The updated version should simply drop the word “nine” and state, *“and one area representative from each of the established TASL regions.”*

This change reflects the update in region structure for TASL from nine to thirteen regions while allowing for future changes without the need to continuously update the bylaws.

President Vicki Winstead asked if there was a motion to accept the first amendment. Martha Harris made a motion to accept and Johnnie Sue Hawley seconded. Motion carries.

Amendment #2:

Proposes changing the wording in Bylaws Article III, A, viii which states that the President *“will attend meetings, either live or virtually, of the TLA as TASL’s voting delegate or appoint a representative.”*

The updated version should simply drop the word “voting” and state, *“will attend meetings, either live or virtually, of the TLA as TASL’s delegate or appoint a representative.”*

This change reflects the fact that there is not an official voting delegate from our organization needed on TLA’s end but we feel it is important to have a TASL member attend the meetings.

President Vicki Winstead asked if there was a motion to accept the second amendment. Johnnie Sue Hawley made a motion to accept and Erika Long seconded. Motion carries.

Amendment #3:

Proposes changing the wording in Bylaws Article V, Section 1 which states, *“through publication in the newsletter one name for each office.”*

The updated version should add the phrase as follows, *“through publication in the newsletter or other communication one name for each office.”*

This change reflects the update that we are primarily using our blog to communicate with membership.

President Vicki Winstead asked if there was a motion to accept the third amendment. Katelyn Jernigan made a motion to accept and Ginny Britt seconded. Motion carries.

Amendment #4:

Proposes changing Bylaws Article V, Section 2 for the required members of the Conference Committee. The Section states, *“composed of the current conference chair, the future conference chair, local arrangements chair and other needed members.”*

The updated version should change to state, *“composed of the current conference chair, the Secretary, and any other committee members chosen by the conference chairperson.”*

This change aligns the requirements with what is stated in the Officer and Committee Handbook.

President Vicki Winstead asked if there was a motion to accept the fourth amendment. Penney Letbetter made a motion to accept and Johnnie Sue Hawley seconded. Motion carries.

Amendment #5:

Proposes changing the wording in Bylaws Article V, Section 3 which states, *“and published in the appropriate committee notebook.”*

The updated version should change to state, *“and published in the Officer and Committee Handbook.”*

This change reflects the fact that committee chair duties are covered completely in the Officer and Committee Handbook.

President Vicki Winstead asked if there was a motion to accept the fifth and final amendment. Johnnie Sue Hawley made a motion to accept and Caroline Mickey seconded. Motion carries.

Changes to Dues Structure

The Executive Board recommends changes to the dues structure as follows:

- Eliminate the two year TASL membership option.
- Change the yearly base membership cost to \$50.
- Increase all \$15 membership categories to \$30
- Increase supervisor and professor dues to \$50
- Increase corporate membership to \$100

President Vicki Winstead asked if there was a motion to accept. Elizabeth Shepherd made a motion to accept and Martha Harris seconded. Motion carries.

The membership report was read on behalf of Martha Harris. TASL currently has 521 active members with membership steadily increasing. The TASL membership year is Jan 1 to Dec 31. Everyone is reminded to renew their membership by January 15 and support TASL by joining a committee.

Katie Capshaw reported that the virtual PD this past summer was a huge success with over 300 people registered. Feedback was very positive and we are looking at doing more with virtual PD in the future, possibly some hybrid PD as well.
